3. The result has been prepared based on the merit position only. Estt.-IV Section of BSNL Corporate Office, being the Cadre Controlling Authority, will allot the vacancy year and seniority to the selected candidates.

4. The concerned Circle will first offer the appointment to the selected candidates for the post of JTO (Telecom). In case of their refusal or found ineligible for the said post, the matter may be immediately communicated to the Recruitment Branch, BSNL CO, so that the offer of appointment may be made to the Wait Listed candidates in the order of their merit position.

5. All candidates who have been selected may be asked to produce their original documents relating to the following for verification in accordance with the Advertisement/Notification issued for the aforesaid SRD examination :-

- i) Medical Certificates for verification as their being Persons With Disabilities (PWD) candidates
- ii) Educational Qualifications
- iii) Age
- iv) Category Certificate in respect of SC/ST/OBC candidates

6. The above action may commence immediately and all actions may be completed in a time bound manner as per the schedule given below :-

- i) Issue of letter to selected candidates for verification of documents and other formalities : 15/01/2016
- ii) Completion of verifications of documents, including Police verification and Medical Examination Certificate etc. : 31/01/2016
- iii) Sending the candidates for pre-recruitment training : 15/02/2016


